



## Consultation/Survey regarding the installation of CCTV Cameras in and around Overstone


The purpose of this consultation is to seek views and gather feedback from individuals, groups and organisations, on the proposal to install CCTV cameras along Sywell Road and Church Lane, for the purpose of reducing crime and incidents such as Anti-Social Behaviour.

A Budget of £3,000.00 has been allocated to the project which will allow for the installation of 3 cameras.

Cameras will be in a fixed position sited atop various Lamp Posts within the village. They will not be able to look or record in any residential property/garden. If necessary, 'privacy screens' will be installed to digitally obscure the relevant views and angles.

It is proposed, footage will not be monitored and will only be accessed should anti-social behaviour or an alleged crime be reported. Recordings are automatically overwritten after a period of time.

Proposed Camera locations are as follows:



- A Sited to the West of the Village on the  $1^{st}$  lamp post as you enter the village camera will be looking inwards towards the village.
- B Sited to the East of the Village on the last lamp post as you leave the village camera will be looking inwards towards the village.
- C Sited on the lamp post outside of the St Nicholas Church camera will be looking in a Northerly direction towards Sywell Rd.

So as to gauge the local response to the above proposal it would be appreciated if you could complete the short survey overleaf (no later than the 1<sup>st</sup> July please).
